- RAA Running Annual Average
- Treatment Technique (TT) A required process intended to reduce the level of a contaminant in drinking water.

   Maximum Residual Disinfectant Level Goal (MRDLG) The level of a drinking water disinfectant below which there is no known or expected risk to health.

### GENERAL INFORMATION

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. ## SOURCE WATER ASSESSMENT INFORMATION

This water supply obtains its water from the buried sand and gravel and sandstone of the Buried Sand and Gravel-Dakota aquifer. The Buried Sand and Gravel-Dakota aquifer was determined to be susceptible to contamination because the characteristics of the aquifer and overlying materials provide some protection from contaminants from the land surface. The Buried Sand and Gravel-Dakota wells will be susceptible to surface contaminants such as leaking underground storage tanks, contaminant spills, and excess fertilizer application.
