

## RESOLUTION NUMBER 2026-01

RESOLUTION ESTABLISHING RATES FOR THE SALE OF WATER BY THE BOARD OF TRUSTEES OF THE ALGONA MUNICIPAL UTILITIES AND REPEALING RESOLUTIONS IN CONFLICT.

It is resolved by the Board of Trustees in charge of management and control of the Municipal Water Utility of the City of Algona, Iowa, to set rates and fees as follows:

### Section 1. Rates and Fees Established.

Delayed Payment: 1.5% interest added 20 days after billing date.

Section 2. Repealer Clause. All resolutions, parts of resolutions, or service rules in conflict with the provisions of this resolution are hereby repealed insofar as the conflicting portions thereof are concerned.

Section 3. Severability Clause. If any section, provision, or part of this resolution shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the resolution as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

Section 4. Effective Date. The rates provided herein apply to water billed on or about March 31, 2026. This resolution shall be in full force and effect upon its passage and publication as provided by law.

Section 5. Publication. This resolution shall be published in full.
