Chairperson Murphy called the meeting to order at 11:01 A.M.

The consent agenda included roll call, adoption of the agenda, approval of the August 1, 2023, regular minutes, approval of the monthly vouchers and uncollectable accounts. Trustee Sabin moved to approve the consent agenda, seconded by Trustee Heupel. Motion carried unanimously.

Trustee Sabin moved to approve easements related to US Highway 18 Water Main Improvements Project, seconded by Trustee Schaaf. Motion carried unanimously.

Trustee Schaaf moved to approve DGR Engineering Existing Plant Generation Addition Study, seconded by Trustee Heupel. Motion carried unanimously.
